**A RESOLUTION OF THE BOROUGH OF OAKDALE,
ALLEGHENY COUNTY, PENNSYLVANIA, AWARDING
THE BOROUGH CONTRACT FOR THE
COMPREHENSIVE REFUSE COLLECTION SERVICE IN
THE BOROUGH OF OAKDALE.**

WHEREAS, the Borough of Oakdale (the "Borough") advertised and invited bids for the grant of a contract for the comprehensive collection system for refuse beginning January 1, 2025 and ending December 31, 2027, with the option for extending the contract up to three (3) additional years, consistent with the Bid Specifications for Comprehensive Refuse Collection Service in the Borough of Oakdale, Allegheny County, Pennsylvania dated August 30, 2024; and

WHEREAS, the Borough advertised the request for bids on August 30, 2024 and September 6, 2024; and

WHEREAS, the Borough held a mandatory pre-bid meeting for all potential bidders on September 9, 2024; and

WHEREAS, following the mandatory pre-bid meeting, the Borough issued Addendum No. 1 to the Contract clarifying questions raised by potential bidders at the mandatory pre-bid meeting; and

WHEREAS, the Borough scheduled the deadline for bid submission and the scheduled bid opening dates for September 23, 2024 and September 24, 2024, respectively; and

WHEREAS, the Borough received bids from one (1) potential contractor for the Collection and Disposal of Refuse and Recycling in the Borough; and

WHEREAS, the Borough held a public bid opening on September 24, 2024; and

WHEREAS, the Borough Council and the Borough have determined from the bid and investigation of the responsibility of the bidders, an appropriate party to be granted the contract;

WHEREAS, by this Resolution, the Borough awards a contract under the terms and conditions spelled out in the bid package, the information to bidders, the bid general specifications, and all addenda associated with the bid package.

NOW, THEREFORE, BE IT RESOLVED that County Hauling, LLC be awarded the contract for the Comprehensive Refuse Collection Service in the Borough utilizing a traditional, manual collection method for all refuse and recycling, and providing for the collection of e-Waste and Bulk Items as specified under the terms and conditions of all contract documents, bid documents, information to bidders, the bid general specifications, and all addenda associated with the Bid Specifications for the Comprehensive Refuse Collection Service in the Borough of

Oakdale, Allegheny County, Pennsylvania dated August 30, 2024. The President of Council and the Borough Manager are hereby authorized to sign the Contract on behalf of the Borough.
